- Corn Taco project NENEDD met with Sabino yesterday. We will be doing a joint loan for his needs, \$25,000 CCL and \$55,000 NENEDD
- Schuyler Golf Course Loan, this loan was approved and has been set up and started by the Schuyler Golf Course.
- ❖ Partnership NENEDD, working with NENEDD on ARPA funds up to \$15,000 for the Center, and working with the Colfax Foundation on a potential 2nd round public works grant for \$250.000.

- Motion to Approve recommendation from the RWHF Fund advisory Committee to approve a loan application by the Schuyler Home builders Group, LLC for a \$125,000 closed-ended line of credit at 4% with a maturity date of October 10, 2024. Motion made by Chris, seconded by Josh, discussion on interest rate, DED lobby efforts needed for RWHF and money left in RWHF fund. Motion carried.
- Mares Property Update, developer looking at property that would have potential for 25 housing units.
- ❖ Macroeconomic Conditions affecting Housing, Brian noted that housing interest rates are up, while construction materials are trending down. Chris noted that 2 houses sold this week at a fixed rate of 6%.
- ❖ Housing Study Updates, we have approximately 180 surveys done, we wanted to get to 200. The survey will stay open for another 10-14 days. RDG has filed a public records act to obtain necessary GIS information for housing study with the county.

ED – Latino – Monty – no report

Directors Round Table – Claudia noted that they are doing a flooring project at the hospital, they are raising money for a 3D mammography machine and that respiratory illnesses are rising.

City of Schuyler Will noted that we will have one new city council person and a new mayor inducted on December 6. Other City items such as ARPA and Public Works had already been discussed.

Schuyler Department of Utilities -no report

Schuyler Chamber of Commerce Audra advised Donkey Basketball was a strong community participation event. Trivia night will be November 19th, Christmas events coming up, Santa's house is being moved in.

Schuyler Community Schools - no report

Brian noted that the Wednesday meeting date has presented some problems with delaying loan procedures.
