- ❖ Addendum: Approval of CCL2022-01, \$50,000 for Golf Course 0%, 5 Years. Discussion the SED plan LB840 plan and variances that were done with this loan. This loan was presented directly to city council, with LRB, SCD approval due to timing constraints, 100% loan value, city owned property. SCD will act as the 501(c) (3) for the fundraising for the golf course for repayment of loan. Discussion, a motion was made by Kevin H., seconded by Javier, approved.
- Executive Search Update Lonnie advised that Carol Ringenberg and Monty Avilez have both accepted SCD offer and will start in October.
- ❖ America's Pathway update Cheryl advised 320 bricks have been sold.
- ❖ Top Notch Task Force, the next meeting is Tuesday August 16. At that time, we hope to have some high-level estimates on outside of building estimates.
- ❖ DRCDC Update, continue to focus on Highway 30 corridor improvements. Demo permit has been issued for property on 11th & Colfax. SCD will be working with County and City for a Joint application for a tire amnesty day in 2023, grant. 2 properties have failed to come into compliance on clean up − Three Star Auto, Nores. Denise advised that a citation needs to be written before any further steps can be taken.
